**MINUTES OF LAST MEETING:** Agreed as correct. Due to adverse weather meeting January 13 cancelled.

**MATTERS ARISING:** *a) Communication* Chair asked that more use is made of website for giving out information, interaction with parents. *b) Subs Collection arrangement* has been successful though some monies still outstanding. County donation for new Sections still not yet received. **GS**

**TREASURER REPORT:** *Copy of accounts enclosed Troop* accounts still needing attention. **GSL** CAF bank set up with Treasurer hoping to retrieve his loan of £3000 soon. Group and Group savings accounts and Beaver account set up, rest after Easter break. **Thanks were expressed to the Treasurer for setting up this**, **GSL** suggested annual collection of subs but Committee, after discussion, decided to continue termly collections but keep annual collections under review.

**POR 82.1** Each Section of a Group must itself administer sums allocated to it by the Group Executive Committee.

**RULE 82.2** Subscriptions paid by members of the Section, or on their behalf, must be handed to the Group Treasurer or his nominee as soon as possible after receipt, who will make the necessary entries in the books of Accounts, and pay the money into the Group Bank accounts as soon as practicable.

**RULE 82.3** Each Section must keep a proper cash account which must be produced, together with supporting vouchers and the cash balance, to the Group Treasurer at least once in each period of 3 months at the request of the Group Treasurer.

**CHAIRMAN'S REPORT:** *Social committee* has met several times and is working well on the Centenary events. **Tree planting** Feb 7 (first event) invitations have been circulated and we look forward to a successful day. **Archive** material has been found and will be returned to Mrs Marion Hill for safe keeping. Concern was raised that future material eg on Digital cameras may be lost so the Chairman will set up a mailing list for an archive webpage in the website for members to deposit items of interest. There is a **calendar page** on the website that shows relevant dates/events for members to consult. Chair asked that reports/minutes/new dates be put on within 7 days of any meeting.
